ARTICLE I - NAME AND ADDRESS

The name of this corporation is POSTMASTER GP, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 7483 S.W. 24<sup>th</sup> Street, Suite 209, Miami, Florida 33155.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the fullest extent permitted by law.




