ARTICLES OF INCORPORATION

OF

D' Casta Flowers, Inc.

ARTICLE I - NAME

The name of this corporation is D' Casta Flowers, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless dissolved according to law and it's existence shall commence on the date of execution and acknowledgment.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of one dollar (\$ 1.00) par value common stock which shall be designated "common shares".
