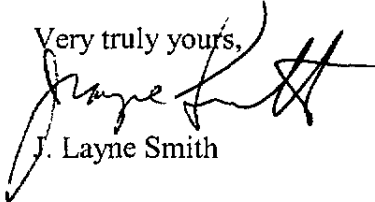

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: JIMMY MARLIN, INC. The address of the principal office of this corporation shall be 271 Rosehill Drive, Tallahassee, FL 32312, and the mailing address of the corporation shall be 1400 Village Square, 3-216, Tallahassee, FL 32312.

**ARTICLE VI. PREEMPTIVE RIGHTS**

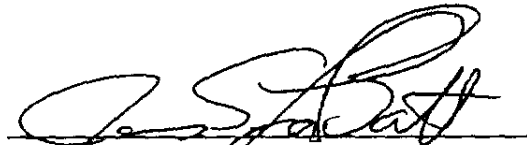
