##### **Indemnification**

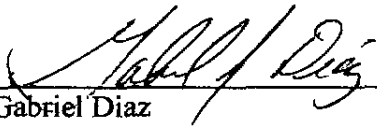
The corporation shall indemnify any officer, director or any former officer or director, to the extent permitted by law.

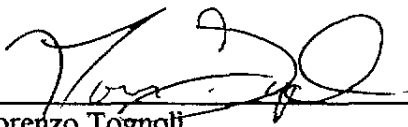
#### **Article XII**
