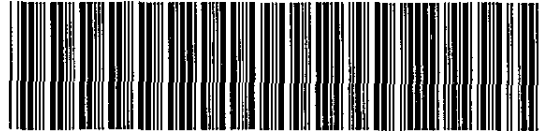

The Name of the corporation shall be **RICO JOHNSON, PA.**, whose principal office shall be located at 928 Chestwood Avenue, Tallahassee, Florida 32303.

II

The duration of the corporation shall be perpetual.

III


