ARTICLE I - NAME

The name of this Corporation is Uncle Mel's Repair Center, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on February 4, 2005.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue One Thousand (1,000) shares of \$1.00 par value common stock.

ARTICLE V - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.


ARTICLE XI - BY-LAWS


