ARTICLES OF INCORPORATION

OF <u>PEREZ TILE, INC.</u>

The undersigned incorporator hereby certifies to the following in order to form a corporation for a profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is, PEREZ TILE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.
