ARTICLES OF INCORPORATION AF STAFE FALL AHASSEE, FLORIDA

OF

HOME INSPECTION GROUP, INC.

The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME AND ADDRESS

The name of the corporation is HOME INSPECTION GROUP, INC. and the principal office address is 156 Melrose Avenue, Ormond Beach, Florida 32174.

ARTICLE II **NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock, each share having the par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors from time to time.

ARTICLE IV REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE V BOARD OF DIRECTORS

This Corporation shall have one (1) director initially. The number of directors may be increased or deceased from time to time by the Bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VI INITIAL DIRECTORS

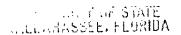
