ARTICLE IX – SHAREHOLDER PROPERTY

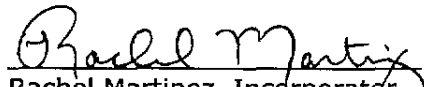

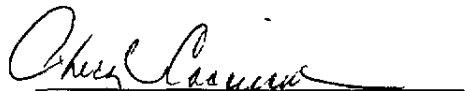
ARTICLE X – CORPORATE POWERS
