

# ARTICLES OF INCORPORATION OF TARYA A. TRIBBLE, P.A.

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

# **ARTICLE I: NAME**

The name of the corporation is TARYA A. TRIBBLE, P.A.

#### **ARTICLE II: EXISTENCE**

The corporation shall have a perpetual existence. The corporation shall begin its existence on February 1, 2005.

#### **ARTICLE III: PURPOSE**

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act and will engage in the practice of law.

#### ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that eh corporation is authorized to have outstanding at any one time is amount 10,000 shares of common stock having a par value of one dollar (\$1.00) per share.

#### ARTICLE V: SECTION 1244 STOCK

#### ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

Tribble, Esquire. The Board of Directors may from time to time move the registered office to any other address in the State of Florida.

#### **ARTICLE VII: INITIAL DIRECTORS**

who shall hold office until the first annual meeting of the shareholders, and until her successor(s) shall have been elected and qualified or until her earlier resignation, removal from office or death.
