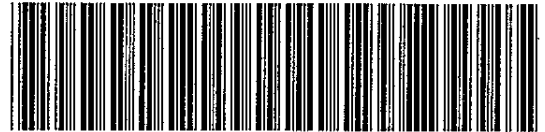



ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is SUMMERLAND DEVELOPMENT CORP. and its principal place of business shall be located at 9318 E. Colonial Dr. #A-4, Orlando, FL 32817.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.


#### ARTICLE XI - AMENDMENT


