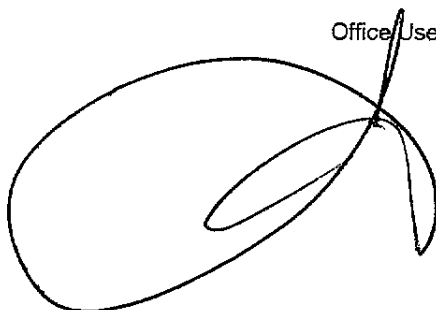

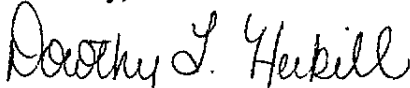

The undersigned incorporators hereby form a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: LEBEAU'S TURF TENDERS, INC.

**ARTICLE II. PRINCIPAL PLACE OF BUSINESS**

The address of the principal office of this corporation shall be 934 South Ridgewood Avenue, Daytona Beach, County of Volusia, State of Florida, 32114, and the mailing address shall be the same.

**ARTICLE III. NATURE OF BUSINESS**

The general purposes for which the corporation is organized are to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

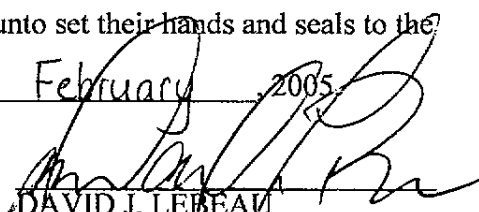

30% to SCOTT S. LEBEAU.

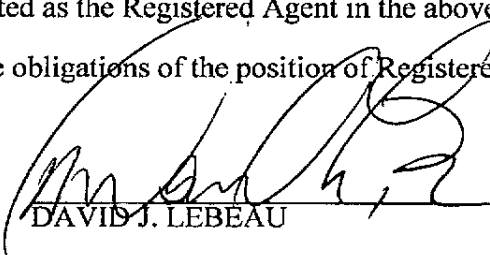

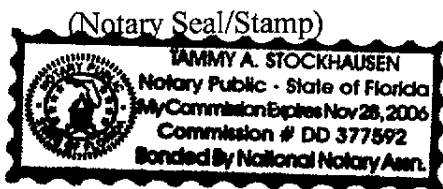
