ARTICLES OF INCORPORATION

OF

LINDA L. ASKUE and W. RICHARD ASKUE, JR., P.A.

We, LINDA L. ASKUE and W. RICHARD ASKUE, JR., the undersigned, being of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, under Section 607 of the Florida Statutes authorizing the formation of corporations.

ARTICLE I - NAME:

The name of the corporation shall be:

LINDA L. ASKUE and W. RICHARD ASKUE, JR., P.A.

ARTICLE II - DURATION:

The corporation shall have perpetual existence beginning with the date of acceptance of the corporation by the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE:

The corporation is organized for the purpose of transacting any or all lawful business within or without the State of Florida, and to have all powers conferred upon the corporation by the laws of the State of Florida. The business conducted by the corporation will be the purchase and sale of real property.

ARTICLE IV - CAPITAL STOCK:

ARTICLE XI - AMENDMENT:

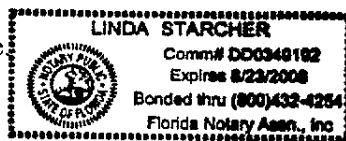


