ARTICLE I. NAME

The name of the corporation shall be as follows:

The principal place of business of this corporation shall be 9050 16<sup>th</sup> Place, Vero Beach, Florida 32960, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation shall engage or transact in any and all lawful activities or business permitted under the laws of the United States; of the State of Florida; or of any other state, country, territory, or principality.

ARTICLE III. CAPITAL STOCK
