ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLES I, NAME

The name of this corporation shall be:

ARTICLE II, NATURE OF BUSINESS

This corporation may engage as licensed real estate agents as permitted under the laws of the United States and the State of Florida.

ARTICLE III, CAPITAL STOCK

This corporation may be a Sub-Chapter S Corporation as defined by the Internal Revenue Code.






