CHANGE OF REGISTERED AGENT:


Yrailis Moraton is hereby *deleted* as Registered Agent of the Corporation.


Otto A. Sanchez-Laine shall be the new Registered Agent of the Corporation at 1401 SW 87th Avenue, Miami, Florida 33174.

The Amended Articles were adopted by a majority of the Corporation's Directors and Shareholders on the date written below.


