# ARTICLES OF INCORPORATION

OF

## **PAMELA LEE RENNER INC**

### ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **PAMELA LEE RENNER INC**, and the principle place of business of this corporation shall be: 5758 21<sup>ST</sup> AVENUE NORTH, ST PETERSBURG, FLORIDA 33710-5038

### ARTICLE TWO - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida. This Corporation shall have all of the powers and privileges general and additional enumerated and conferred upon Corporations generally by Chapter 607 (also referred to as the Florida General Corporation Act), Florida Statutes 1977 and any amendments thereto.

### ARTICLE THREE - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series of that which he already holds, shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

### ARTICLE FOUR - CAPITAL STOCK

The aggregate number of shares which this corporation is authorized to issue is 300 shares of common stock with a par value of one dollar (\$1.00) per share. The shares may be divisible and may be issued as fractional shares.
