#### ARTICLES OF INCORPORATION OF

NuAge Auto Detail, Inc.

### ARTICLE I - NAME

The name of this corporation is NuAge Auto Detail, Inc.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence unless sconer dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of State of Florida.

#### ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
