

ARTICLES OF INCORPORATION

OF

FRANK PAUL MORA OF BREVARD, INC.

ARTICLE I - NAME

The name of the corporation is Frank Paul Mora of Brevard, Inc., at 2000 So. Banana River Drive, Merritt Island, FL 32952 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
