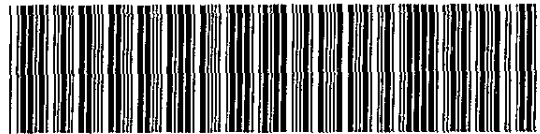



I, the undersigned, as a proper person acting as an incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

First

The name of the corporation will be Color Blind Painting, Inc.

Second

The period of its duration is in perpetuity.

Third

The purpose of the corporation is to conduct business performing painting services.


