**ARTICLES OF INCORPORATION
OF

Article I. Name and initial Address.

The name of the Corporation is: KENNETH GORDON KING, P.A.

with its initial business address being: 720 Orchid Dr.
Naples, Florida 34102

Article II. Duration.

The Corporation shall exist perpetually commencing on the date of execution and acknowledgment of these Articles.

Article III. Purpose.

This corporation is organized for the purpose of transacting any and all lawful business within this state and otherwise, as determined by its Director and sole proprietor, manager and practitioner, Kenneth Gordon King, Attorney at Law (Fla. bar no. 967815), and for the purpose of the operation of a Florida law practice and all functions associated therewith.

Article IV. Capital Stock.

This corporation is authorized to issue Ten Thousand (10,000) shares of capital stock, initially valued at one and no/ 100 dollars (\$ 1.00) per share of common stock, and initially assigned as provided herein.

Article V. Rights of Shares of Capital Stock.

Section I. Dividends

The corporate Director may declare and pay dividends upon the common shares according to his discretion and valuations.

Section 2. Rights upon Liquidation

In the event of any dissolution or involuntary liquidation, dissolution, sale or other winding up of this Corporation, and after payment or satisfaction of all valid corporate debts, the remaining assets of the corporation shall be payable to and distributed to the shareholder of common stock, Kenneth Gordon King.

Section 3 - Voting Rights

Except as otherwise provided at law, the entire voting power for the election of directors, designation of officers, determination of corporate policy and for any and all other acts and purposes of the corporation shall be vested exclusively in the holder of the outstanding common shares.

Section 4. Issuance of Capital Stock

Upon determination of the shareholder and director, the Corporation is authorized to issue, dispose of, transfer and increase the issue of capital stock within its treasury or among its shareholders in the event of merger, as provided herein and to annually determine the par value of all shares.

Article VI. Preemptive Rights

Every shareholder, upon the sale or issue of additional stock or other transaction affecting the allocation of shares, shall have the right to purchase his/her pro rata share thereof at all times, as nearly as may be done without issuance of fractional shares, at the price at which it is offered or issued to others.

Article VII. Designation of Registered Agent and Registered Office.

The initial Registered Agent of the Corporation and the initial registered mailing address for such purposes shall be:

Article VIII. Initial Board of Directors.

The Corporation shall have one director, the name and address of whom is the registered agent and shareholder, Kenneth Gordon King, holder of all Ten Thousand shares.

Article X. Amendment.

This Corporation through its director reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any Amendment thereto.
