5. **ARTICLE V SHARES**

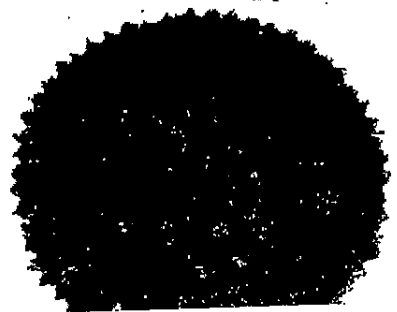

6. **ARTICLE VI CAPITAL**

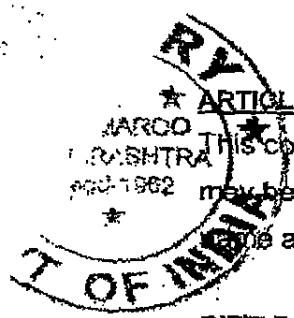

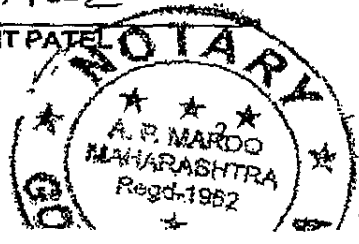
