

ARTICLES OF INCORPORATION OF:

## INSURANCE HOUSE AGENCY CORPORATION

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 697 of the Florida Statutes.

#### ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. - 3. No shareholder of the Corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

## ARTICLE IX POWER OF CORPORATION
