ARTICLE I - NAME

The name of this corporation is **Damada II Inc.**(the "Corporation").

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any activity or business permitted under the laws of the United States and the State of Florida.

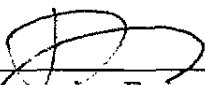
