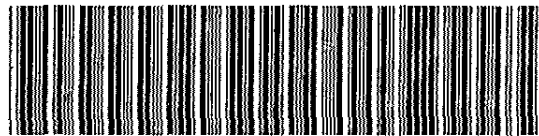

## **ARTICLES OF INCORPORATION**

## **DYNASTY LIMOUSINE SERVICE BUSINESS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### **ARTICLE I**

The name of the corporation ("Corporation") is Dynasty Limousine Service Business, Inc.

### **ARTICLE II**

The existence of the corporation shall begin on February 1, 2005 and last perpetually.

### **ARTICLE III**
