

ARTICLES OF INCORPORATION

JCB DRYWALL, INC

ARTICLE I. Name. The name of this corporation is JCB DRYWALL, INC.

ARTICLE II. Commencement and Duration This corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III. Purposes. This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. Stock Issuance. The maximum number of shares this corporation is authorized to issue is five thousand (5,000) common par value \$.01 per share, all of which shall be Common Shares.

ARTICLE V. Board of Directors.
