ARTICLES OF INCORPORATION

OF

JCB DRYWALL, INC

ARTICLE I. Name. The name of this corporation is JCB DRYWALL, INC.

ARTICLE II. Commencement and Duration This corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III. Purposes. This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. Stock Issuance. The maximum number of shares this corporation is authorized to issue is five thousand (5,000) common par value \$.01 per share, all of which shall be Common Shares.

ARTICLE V. Board of Directors. All corporate power shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors. This corporation shall have one director constituting its initial board of directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one director. ARTICLE IX. Amendment. These articles of incorporation may be amended at any time by a vote of the majority of the voting stock of the corporation outstanding, at any regular meeting of the stockholders or at any special meeting of the stockholders called for that purpose.

ARTICLE X. Incorporator. The name and address of the Incorporator to these articles of incorporation is:



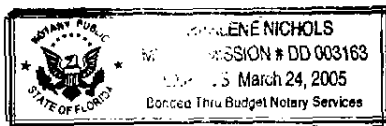


