

# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I

The name of the corporation is VIRTUAL OPEN HOMES, INC.

#### ARTICLE II

The duration of the corporation is perpetual.

#### ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV

The amount of capital stock of this corporation shall be ONE HUNDRED SHARES (100) at One Dollar (\$1.00) par value stock, which stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine.
