Article VII is hereby amended to read:

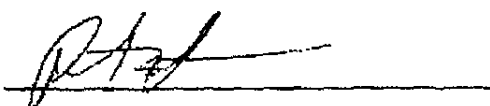
ARTICLE VII

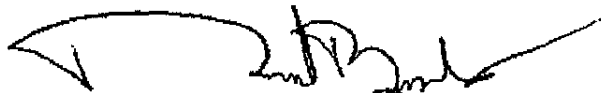
