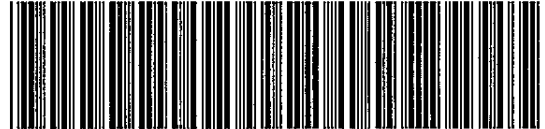

2. The foregoing Amendment was adopted by all shareholders, officers and directors of this corporation on the 21st day of September, 2005.


