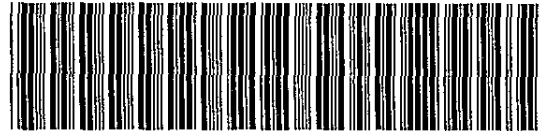

ARTICLES OF INCORPORATION
OF
BACK BAY MANAGEMENT, INC.

The undersigned, desiring to form a corporation for profit under the laws of the State of Florida, hereby certifies:

FIRST: The name of the corporation shall be:

BACK BAY MANAGEMENT, INC.

SECOND: The place in Florida where its principal office is to be located is: 1040 Bayview Drive, Suite 428, Fort Lauderdale, Broward County, Florida 33304.

THIRD: The purpose for which the corporation is formed is to engage in any lawful act or activity for which corporations may be formed under the laws of the State of Florida.

FOURTH: The maximum number of shares which the corporation is authorized to have outstanding is Six Thousand (6,000) shares which shall consist of:

- (a) Six Hundred (600) shares shall be Class "A" common shares, \$.10 par value, and shall possess all of the voting rights of the corporation as hereinafter determined; and
- (b) Five Thousand, Four Hundred (5,400) shares shall be Class "B" common shares, \$.10 par value, and shall be non-voting.
- (c) The express terms of the shares of each class are as follows:
 - (1) No dividends shall be declared or paid on any class unless at the same time there shall be declared or paid, as the case may be, a dividend in the form of cash or property in an equal amount per share on the other class;
 - (2) In the event of a share dividend the dividend shall be payable in the same class;
 - (3) No holder of shares of the corporation shall have a preemptive right to subscribe for or to purchase any shares of any class of the corporation whether now or hereafter authorized; and
 - (4) Each class of shares shall be treated equally upon the dissolution, termination or winding up of the corporation.


FIFTH: The amount of stated capital with which the corporation shall begin business is Five Hundred (\$500) Dollars.
