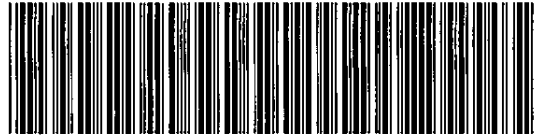

Please be advised that Jammin Juices & Pastries have been closed since January 31, 2008 with a view at reopening.


This reopening did not materialized and so I notified the IRS – Sales Tax Department, not realizing that I need to notify the Department of Corporation. For this error I apologise.
