

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

# ARTICLE I. CORPORATE NAME

The name of this corporation shall be ROBERT D. FLURRY, M.D., P.A.

# ARTICLE II. INITIAL PRINCIPAL OFFICE

The street address, and the mailing address of the initial principal office of the Corporation is: 9290 Baldridge Road, Pensacola, Florida 32514.

#### ARTICLE III. CAPITAL STOCK

The number of shares the corporation is authorized to issue is 7,500. No preemptive rights are to be granted to shareholders.

#### ARTICLE IV. REGISTERED OFFICE AND INITIAL REGISTERED AGENT
