Article VI - Board of Directors

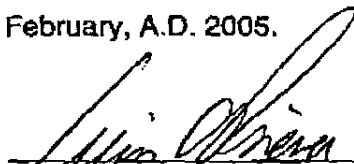
Article IX – Amendments to Article of Incorporation

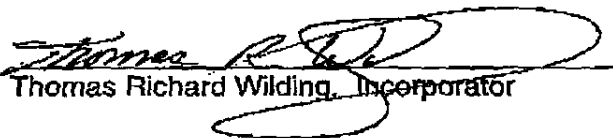
These Articles of Incorporation may be amended solely by a 60% vote of the shareholders of the Corporation.

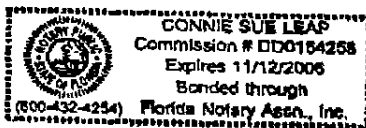

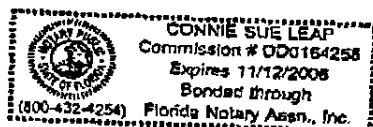
