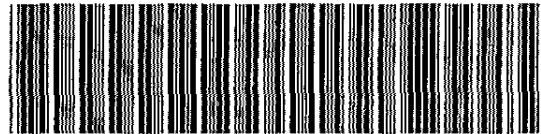

The Undersigned hereby execute these Articles of Incorporation for the purpose of incorporating in compliance with Chapter 607 and/or Chapter 621, F.S.

Article I: NAME

The name of the corporation is **BLACKBERRY, INC.**

Article II: PRINCIPAL OFFICE
