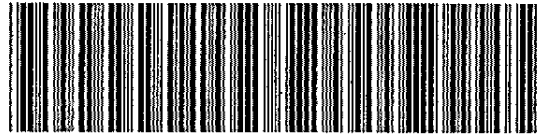

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is SDA INTERNATIONAL, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on February 3, 2005, or the date of filing whichever first occur.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".



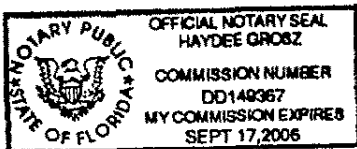


