Articles of Incorporation

Article I Name The name of the Corporation shall be:

Article II Principal Office The principal place of Business/ mailing address is:

Article III Purpose The purpose for which the corporation is organized is:
Render professional services for compensation for selling, exchanging, buying, renting, appraising, auctioning of business enterprises or business opportunities or real property and any other real estate services allowed and defined in Chapter 475 and/or other related Florida Statutes governing the services allowed for real estate professionals. This purpose does not limit the corporation from investing its funds in real estate, bonds or other types of investments allowed by Florida and Federal law.

Article IV Capital Stock The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock, having One Dollar (\$1.00) par value.

The number of directors may be either increased or decreased from time to time by the Bylaws, adopted by the Stockholders but shall never be less than one. 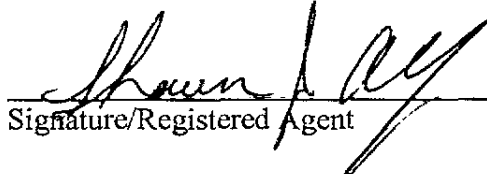
