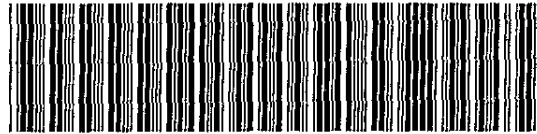

**ARTICLES OF INCORPORATION


