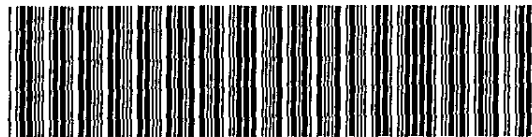



ARTICLES OF INCORPORATION
OF
PEADEN FLOOR COVERING, INCORPORATED

In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is PEADEN FLOOR COVERING, INCORPORATED.

ARTICLE II

The existence of the Corporation shall begin on the day the Articles of Incorporation are filed with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 6938 Singletary Street, Grand Ridge, Florida 32442. The mailing address of the principal office of the company shall be: Post Office Box 28, Grand Ridge, Florida 32442.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 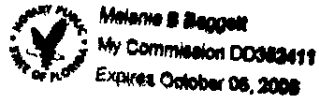


