The undersigned natural person, who is licensed to practice law if the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such corporation.

ARTICLE I - CORPORATE NAME AND PRINCIPAL OFFICE

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE AND POWERS

ARTICLE VIII - BY-LAWS

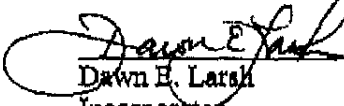
The power to adopt, alter, amend or repeal the by-laws of this corporation shall be vested in the board of directors and shareholders.
