**ARTICLES OF INCORPORATION
OF

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **West Coast Cooling, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Hillsborough County, the principal place of business and street address of this corporation shall be: **7210 Armand Drive - Tampa, Florida 33634**


