CHANGE OF REGISTERED AGENT/REGISTERED OFFICE:

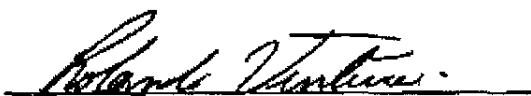
Rolando Ventura of 13122 SW 57 Terrace, Miami, FL 33183 shall be deleted as Registered Agent/Registered Office of the corporation.
