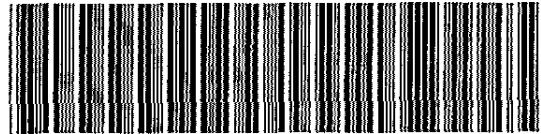

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is FAT BOY'S PIZZA, SUBS & WINGS, Inc., and the principal address and principal place of business is 9427 Corporate Lake Drive, Tampa, Florida 33634.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
