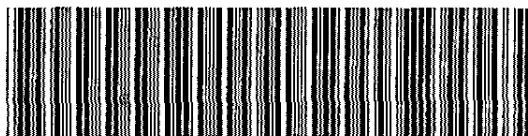

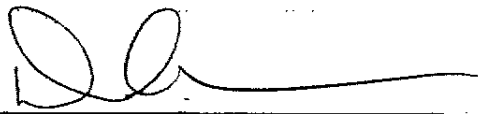
ARTICLE XI
