

## <u>ARTICLE I</u>

The name of the corporation is DESIGNERS CONFECCIONS BY **NICOLE, INC.** The address of the corporation is 18103 SWAN LAKE DRIVE, LUTZ, FLORIDA 33549.

#### ARTICLE II DURATION

The corporation shall have perpetual existence.

#### ARTICLE III **PURPOSE**
