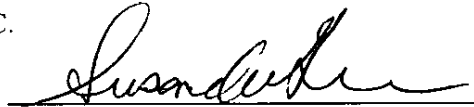

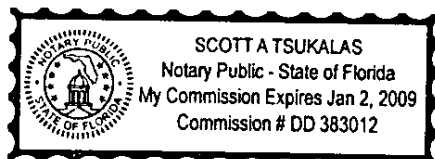
1. Susan A. Green is the President of GRATTON AND GREEN ENTERPRISES, INC., a Florida corporation, (hereinafter "Corporation").
