ARTICLES OF INCORPORATION

FIRST: The name of this corporation is Hanger 55, Inc. The corporate address shall be 2865 Executive Drive, Clearwater, FL 33762.

SECOND: This company is organized for the purpose of transacting any and all lawful business.

THIRD: This company is authorized to issue One Thousand (1000) shares of capital stock with a par value of One (\$1.00) Dollar per share, and any and all shares issued by the company shall be deemed fully paid and non-assessable and the holder of such issued shares shall not be liable to the company or of its creditors in respect thereto.

FOURTH: The amount of capital with which the company shall commence business is Five Hundred (\$500.00) Dollars.

FIFTH: The existence of this company is to be perpetual, or until dissolved by law.


for dividends a reserve or reserves for any proper purpose or to abolish any such reserve in the manner in which it was created.






