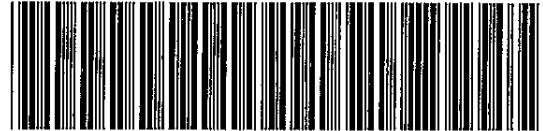

ARTICLE I - NAME

The name of this corporation is BMZ Trading, Inc.
