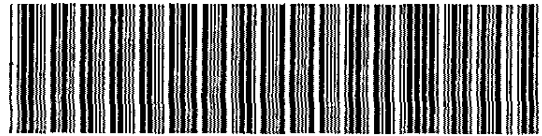



**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of this corporation is Abe Abreu, Sr., P.A., and its initial principal office location and mailing address is 5877 Ferrara Drive, Sarasota, Florida 34238.

**ARTICLE II
DURATION**

This corporation shall exist perpetually.

**ARTICLE III
PURPOSE**

This corporation is organized for the following purposes:


**ARTICLE VIII

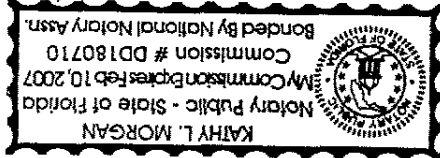


