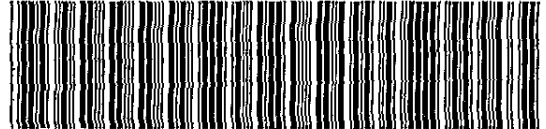

Pursuant to Section 607.1005 of the Florida Statutes and in compliance with Chapter 607 of the Florida Statutes, the undersigned Incorporator submits these Articles of Amendment adopted by the incorporator on March 10, 2005. Shareholder approval is not required.

**Article I - Name**

The name of this corporation is Hillsboro Acquisition Corporation (the Corporation”).

**Article II – Principal Office**
